

**CITY OF CONCORD  
TRANSPORTATION POLICY ADVISORY COMMITTEE  
MINUTES OF February 26, 2026**

The Transportation Policy Advisory Committee (TPAC) met at 6:00 pm on February 26, 2026, in City Council Chambers, 37 Green Street.

**1. Call to Order**

Bakos called the meeting to order at 6:03 pm.

**3. Approval of Minutes**

Approval of Minutes – January 22, 2026

On a motion made by Todd, seconded by Schultz, the meeting minutes of January 22, 2026 were approved as amended. All in favor.

**5. TPAC Referrals from City Council, Staff and Chair**

**6. New Business**

**a. Review CIP Project Scoring**

Bakos summarized the history of the weighting and scoring development process and the intent of the overall project rankings.

Hill noted that in the scoring provided by Staff, the newest, and fifth category for other/bonus was included in the weighting average, but was missing in the scoring sheets that were distributed. Hill suggested that the Committee discuss if they would like to re-evaluate with this category.

Bakos noted that the weight of the other/bonus category is very low, and would make a minimal difference in the rankings.

The Committee generally agreed that the weight averages were pretty much as expected and aligned with individual assessments.

It was discussed that next year, prior to distribution, the Committee should look at the categories and associated wording for clarity.

The Committee discussed some benefits of considering cost and funding components of the projects, including whether a project is eligible for Federal/State 80% cost-share. It was noted that funding sources can change. No changes requested at this time.

Schultz made a motion, seconded by Todd, to approve the average weights as presented with the exception to remove the weight of the other/bonus and add 2% to the remaining four categories. All in favor.

Todd asked if last year's ranking can be added to the summary to more easily see which projects moved in the ranking.

McGregor noted that Regional Drive/Chenell Drive moved up 3 spots, possibly due to the recent evaluation of the speeds and safety concerns along the corridor.

Councilor Todd noted that CIP 590 also moved up 4 spots from last year.

Councilor Schultz made a motion, seconded by Councilor Foote, to approve the project scoring and recommend to Council with a report. All in favor.

**9. General Updates**

**a. City Council Meeting**

Todd provided an update from the February City Council meeting:

- The Loudon Road at Woodcrest Heights intersection report was accepted.

The Committee discussed certain challenges associated with Loudon Road and look forward to supporting any studies that could assist in the effort to improve the safety of the corridor. Noting that the corridor remains to be the most dangerous in the City and public support will be essential for any project to move forward.

The Committee discussed the idea of adding Loudon Road to a future meeting to begin discussion and education of the corridor.

**b. Bicycle/Pedestrian Subcommittee (TPAC-BP)**

No updates provided, the Subcommittee has not met since the last meeting.

c. Traffic Operations Committee (TOC)  
Hill shared the latest TOC meeting agenda in the packet, no further discussion.

d. Public Transportation (CAT)

**10. Project Updates (Staff)**

a. CIP #588 – Loudon Road Bridge

Bezanson mentioned that 60% design plans are under review. They are hoping to complete NEPA documentation soon to be able to move forward with final design. An updated estimate will be included for Council to review during budget review.

b. CIP #283 Traffic Signal Improvements

Hill shared that the signal replacement project received 1 bid and the City is currently evaluating.

c. CIP #31 McKee Square

Bezanson shared that the City is still working with the State on the project and has no new updates.

**11. Other Discussion Items**

Bass noted that the City received 3 bids for the Master Plan RFP and is currently evaluating.

McGregor noted that the house at Broadway at South Main has again been struck by a vehicle, and two other accidents were observed on Broadway. Noting that there are provisions in the City's Traffic Calming Manual that could be applied and thinks the Committee should consider an evaluation at a future meeting.

Bakos noted that in the past the City studied traffic calming on Broadway and the Community decided not to move forward and to "Keep Broadway Broad".

Hill noted that the Broadway @ Wiggins crash came up at the February TOC meeting and that the crash involved an impaired driver.
