CREATING AN EVERETT ARENA ADVISORY COMMITTEE

The City of Concord ordains as follows:

~~Section 1: Amend the Municipal Code of Ordinances, Title V, Administrative Code, Article 30-3, Boards and Commissions, by adding thereto the following new section:~~

~~30-3-10 Everett Arena Advisory Committee~~

~~(a) The Everett Arena Advisory Committee shall consist of seven members. The Manager of the Arena shall be the Clerk of the Committee. The members of the Committee shall be appointed as follows:~~

~~1. Six (6) members shall be nominated by the Mayor and be subject to approval by the City Council:~~

~~(1a) One member representing those using the Arena for hockey;~~

~~(1b) One member representing those using the Arena for non-hockey ice skating;~~

~~(1c) One member representing those using the Arena for non-skating purposes;~~

~~(1d) Three members representing the general public;~~

~~2. One City Councilor to be appointed by the Mayor;~~

~~3. The Director of Recreation and Parks as Ex-officio, non-voting member.~~

~~4. The Committee shall elect its own Chairman and Vice Chairman~~

~~(b) The Committee shall:~~

~~1. submit an annual report to the City Council on the state of the Arena;~~

~~2. initiate and update a five-year needs and improvements plan for the Arena;~~

The City of Concord ordains as follows:

3. initiate a plan for community funding;

4. recommend to the City Manager more creative uses of the Arena that will provide additional revenue and that would, at the same time, encourage tourism and enterprise in the private sector.

5. recommend to the City Manager changes that will result in improvements to all aspects of the operations, use and maintenance of the Arena.

(c) The City Council representative shall serve a two-year term; Other members shall be appointed for three-years.

Section 2: In the first instance the appointment of the members shall be as follows; thereafter they shall be appointed as provided in Section 30-3-10(c):

(a) The member representing the hockey interest shall be appointed for a three-year term.

(b) The member representing the non-hockey iceskating interest shall be for a one-year term.

(c) The member representing the non-skating users shall be for a two-year term.

(d) Members of the general public shall be appointed for a three-year, two-year and one-year term.

Section 3: Amend the Municipal Code of Ordinances, Title V, Administrative Code, Article 30-3, Boards and Commissions, Section 30-3-1, Organization, by inserting in said subsection (a) the following new title:

(9) Everett Arena Advisory Committee


