In case of abandonment or discontinuance, the cost of work performed under a permit may be estimated, an adjustment of the fee made and the portion of the fee for uncompleted work returned to the permit holder, provided that no refund of the prescribed application fee listed in Section 26-14-9(b) shall be made. If such discontinuance is due to revocation of the permit, a similar adjustment and return may be made, provided that no refund shall be made until all penalties and legal costs incurred or imposed by due authority have been collected.

Any request for a refund shall be made in writing. In no case shall a refund be made for a request submitted later than one (1) year after the date of issuance of the permit, nor shall the amount exceed eighty percent (80%) of the original fee paid as calculated on the unit prices in Section 26-14-9(b). After such a refund has been made, no work shall be resumed until a new application has been made and a new permit has been issued.

If work requiring an electrical permit under this Section is undertaken prior to the issuance of a permit, the fee shall be increased by twenty-five percent (25%) for a company's or individual's first such occurrence, fifty percent (50%) for a second occurrence, and b one hundred percent (100%) for any subsequent occurrence.
