- TO APPLY FOR A NEW LIBRARY CARD, PLEASE COMPLETE THIS APPLICATION AND PRESENT IT TO A LIBRARY STAFF MEMBER, ALONG WITH A PARENT OR GUARDIAN'S PHOTO ID AND PROOF OF LOCAL ADDRESS. SEE BACK OF THIS FORM FOR EXAMPLES OF ACCEPTABLE ID & ADDRESS DOCUMENTS.
- CHILDREN'S CARDS ARE VALID FOR THREE YEARS.
- THERE IS NO LOWER AGE LIMIT, BUT THE APPLICANT MUST BE ABLE TO WRITE (PRINT) THEIR OWN NAME ON THE BACK OF THEIR LIBRARY CARD.

ADDITIONAL INFORMATION:

TO OBTAIN A FREE CHILD RESIDENT LIBRARY CARD, THE APPLICANT'S PARENT OR GUARDIAN MUST PROVIDE A PROOF OF IDENTITY AND PROOF OF RESIDENCE IN CONCORD OR PENACOOK, NH.

A valid driver's license or non-driver's identification card issued by the state of New Hampshire, which includes the current local address, is sufficient to serve as both ID and proof of residence.

-OR-

If the applicant's parent or guardian does not have a valid New Hampshire license/non-driver identification card listing their current local address, they must present one form of photo identification **as well as** one form of address verification.

Acceptable forms of photo identification include:

- Passport (from U.S. or another country)
- Alien registration card ("green card")
- Government-issued ID (e.g. military ID)
- University or school ID
- Driver's license or non-driver identification card issued by a state other than New Hampshire

Acceptable forms of address verification include:

- Rental, lease, or mortgage agreement
- Utility bill
- Vehicle registration
- Rent or mortgage receipt including applicant's name and address
- Concord property tax bill or receipt
- Checking or savings account statement
- Change of address form from US Postal Service
- Letter from a social services provider, temporary housing provider, or short-term residence, dated in the last 30 days and verifying applicant's residency at the stated address, or
- Postcard sent from CPL to the address provided, then returned to the library

A business address or post office box may be used for mailing purposes, as long as proof of a legal, physical Concord or Penacook address has been provided.
