JOB SUMMARY:

Performs administrative and clerical work of moderate difficulty involving typing, filing, and assisting the public with inquiries, complaints, and problem resolution. An individual in this classification may be required to compile information from a variety of sources and prepare reports, track documents, and research answers to questions related to the area of assignment.

ESSENTIAL JOB FUNCTIONS:

Answers telephones and directs calls or assists callers.

Assist with all opening and closing procedures, directly responsible for timely reconciliation of prior day business and reporting to Collections Department.

Assist in tournament operations and weekly events including planning, pre-outing contracts, post-tournament billing, promotion, preparation, and follow up.

Assist with the administration of applicable staff via recordkeeping, work schedules, etc.

Assist in coordinating golf activities with food & beverage vendor/contractor

Assist in the inventory control of hard goods, soft goods, and special orders including: ordering procedures, receiving procedures, inputting into point of sale, pricing procedures, display, and sales.

Update website and social media as needed.

Assist with golfer check-in and fee collection as needed

Assists customers as needed.

Composes and types letters as needed.

Updates and maintains files.

Opens and distributes mail.

Photocopies materials.

Prepares mailings.

Performs other related duties as assigned.
