JOB SUMMARY:

Performs a variety of skilled and semi-skilled maintenance and repair work on a wide variety of gas and electric engines, power tools, and turf maintenance and athletic field equipment used throughout the city.

ESSENTIAL JOB FUNCTIONS:

Adjusts and rebuilds small gasoline and diesel engines and systems on a variety of specialized golf maintenance equipment such as professional greens mowers, triplex greens mowers, light weight fairway mowers, trim mowers, articulating wide area rotary mowers, greens and fairways aerators, computerized chemical sprayers, slicer seeders, and others; repairs and maintains industrial tractors and loaders; performs testing and repairs on small electric motors and systems.

Sharpens, grinds, adjusts, and repairs reel lawn mowers using specialized grinding equipment; repairs, maintains and rebuilds hydrostatic transmissions, hydraulic control valves, hydraulic motors, pumps, and hoses.

Troubleshoots and repairs simple and complex electrical system problems.

Repairs small engine equipment such as chain saws, compactors, abrasive saws, compaction rollers, large mowers, sweepers, weed string trimmers, generators, and other similar machinery.

Fabricates tool fixtures from designs and makes modifications to customize tools for equipment repair; performs gas and electrical welding.

Orders parts and supplies; maintains an inventory of parts, equipment, and supplies.

Investigates discrepancies using precision measuring tools.

Performs maintenance and routine repair work on municipal buildings such as repairing steps, fences, and doors; maintains and repairs plumbing and heating systems; paints interior and exterior surfaces; completes minor construction on small buildings.

Repairs, adjusts, and rebuilds golf carts; performs preventative maintenance of golf course trucks; repairs and maintains pesticide spray equipment.

Maintains repair and maintenance records with computerized data processing systems such as word processing, spreadsheet, and database programs.

Performs other related duties as assigned.

MINIMUM QUALIFICATIONS REQUIRED:

Education and Experience: High School diploma or GED; and, additional vocational training in engine repair, carpentry, plumbing, and/or electrical repair; and, two years of experience in skilled and semi-

skilled trades maintenance and repair work; or, any combination of education, training and experience, which provides the knowledge, skills and abilities, required for the job.

Licenses and Certifications:

Must be able to obtain a valid NH Class (B) Commercial Driver's License with air brake endorsement within six months of employment.

KNOWLEDGE, SKILLS, AND ABILITIES:

Knowledge of:

Tools, methods, and materials used in skilled and semi-skilled maintenance trades.

Occupational hazards and safety precautions.

Skill in:

Use of hand tools, shop tools, and maintenance equipment.

Mechanical aptitude.

Mental and Physical Abilities to:

Perform strenuous physical work.

Follow written instructions.

Establish and maintain effective working relationships with other workers.

Perform duties while intermittently sitting, standing, stooping, bending, walking, or crouching.

Frequently lift light or heavy objects.

Climb ladders.

Use tools or equipment requiring a high degree of dexterity.

Distinguish between shades of color.

Working Conditions:

Work is performed in a very noisy place.

Work exposes the employee to dust, dirt, grease, machinery with moving parts, and irritating chemicals.

Work is performed outdoors, occasionally in cold or inclement weather.

Work requires the use of protective devices such as masks, goggles, or gloves.
