Household Hazardous Waste

Household products that are toxic, ignitable, corrosive, or reactive are hazardous waste that do not belong in your trash, down the drain, or on the ground. This includes: pesticides, adhesives, cleaners, polishes, fuels, oil-based paints, etc. Hazardous wastes can contaminate our environment and impact public health if not disposed of properly. Please dispose of these materials at the City of Concord's Annual Household Hazardous Waste Collection Day. Learn more at www.concordnh.gov/hhw.

Needles/Sharps/Syringes

Place used sharps in a strong, plastic container. When the container is 3/4 full, put the lid on and seal it with duct tape. Label it as "SHARPS" and "DO NOT RECYCLE." Put the container in your trash, not your recycling. NEVER throw sharps loosely into the trash. Learn more at www.safeneedledisposal.org/states/new-hampshire.

Prescription Pills

Drop off unused, unwanted, or expired prescription drugs at any time in the permanent "Drug Take Back" Box installed in the lobby of the Concord Police Department. No questions will be asked of anyone dropping off medication. All solid dosage pharmaceutical products and liquids in consumer containers will be accepted. This includes all controlled and non-controlled drugs, over the counter medication, and liquids such as cough syrup. Items that are not accepted include intravenous solutions, injectable, syringes, aerosols, or inhalers. No illicit substances will be accepted. Yard Waste

Yard waste includes grass, grass clippings, leaves, pine needles, cones, and trimmings. In New Hampshire, yard waste is banned from being disposed of in landfills and cannot be included with regular trash. The City of Concord provides a spring and fall leaf collection program for residential properties to properly dispose of yard waste to be recovered into mulch materials. Branches, debris, grass clippings, or leaves can also be taken to Gelinas Excavation & Earth Materials Recycling Center. Learn more at www.concordnh.gov/leafcollection.

Reduce, Reuse, Recycle

Your first step to managing your waste should always be to reduce your consumption to decrease the amount of trash generated. If you don't need it, don't buy it or use it. Your second step is to find new ways to reuse materials before throwing it away. Consider donating or gifting items you no longer use or want, or repurposing them for different functions that you can use. After an item has lived out its course, then recycling should be the last step to consider to turn something old into something new again.
